I would like to express my sincere appreciation to the members of the Nassau County American Legion for your continued support of the Nassau County American Legion Scholarship.

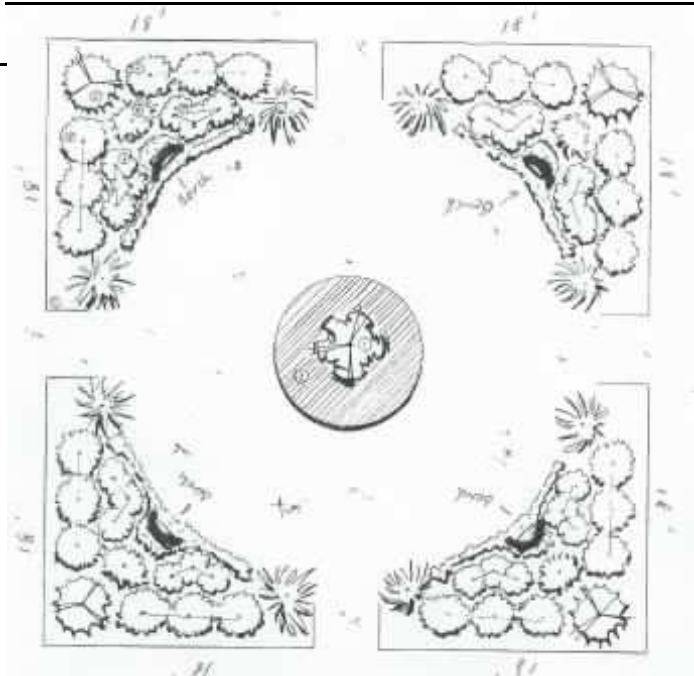
**NATIONAL CEMETERY -

The April 22nd meeting at the cemetery was well attended. We covered all the plans for Memorial Day Ceremonies and we also went over the new proposed layout for the Memorial Garden that was presented by Mel Hennen's daughter Cheryl Ann Lombardo, who did a beautiful job. A committee was set up to define the costs and timetable for the garden's completion. It was determined that the flowers & shrubs would cost approximately \$3,200.00 wholesale and letters will be sent to the L.I. Nursery association to see if we can get some or all of the items donated. If not, we will have to seek donations from the LINCMO Organizations to pay for the needed flowers and shrubs. The (4) benches would cost an additional \$4,500.00 which includes shipping, the memorial plaque and the footings to be installed. We estimate the TOTAL cost to be about \$7,500.00. The area is a 40 x 40 foot area between the two chapels. We are shooting for a September completion.

As for the maintenance and upkeep of this area Cheryl informed us that it would be planted and maintained by the Master Gardeners of Cornell.

**SOLDIERS FOR SOLDIERS CELL PROGRAM  
REGINALD BUTT, JR. PCC**

A letter has been sent to all Posts, Past County Commanders and the County Staff announcing the termination of the Soldiers for Soldiers Program. The following was received from National Headquarters. "Effective April 3, 2007 the relationship between The American Legion and the Soldiers For Soldiers is terminated."

We have had a good relationship with the Soldiers For Soldiers since October 2004 as far as collecting empty ink cartridges and cell phones for the benefit of military service personnel and veterans programs. Because of a recent change in the Soldiers For Soldiers Program management structure and business operations, it is in The American Legion's best interest to not continue this relationship"

Before I received this information I shipped out 247 cell phones bringing the total to 1157 cell phones and 243 ink jet cartridges. I have 38 ink jet cartridges and 30 cell phones that I did not get to ship. The recycling center ECO-CELL sent an E-mail inviting us to continue to send the cell phones to them and they will send to money directly to us to use for any program we desire. I will contact the recycling center and sign up, as they have confirmed our status will remain the same as before except the money will come directly to us. So continue to bring the cell phones to the County Meetings and I will ship them out as before.

The Town of Hempstead Flyer had an article stating the town had four drop off places for cell phones which would go to The American Legion. It stated the cell phones would be reworked to be sent to the troops in Iraq and Afghanistan. I corrected this with the town and a new article was to be placed in the next flyer. The troops can not use cell phones in Iraq and Afghanistan as there are no cell towers in those countries. This is another case of wrong information being put out. If you are not sure of what the programs are, call the program chairman for the correct information. This will stop or avoid any embarrassment to The American Legion.

The UVO passed out 11 pages of information concerning veterans legislation that was introduced in the 110th Congress. 79 bills were introduced in the House of Representatives and only three (3) passed (some didn't even have cosponsors) and two (2) of the three that passed were referred to the Senate.

### Will The VA Pay My Non VA Medical Bills?

VA may authorize veterans to receive care at non-VA health care facilities when needed services are not available at the VA health care facility. Non-VA care must be authorized by VA in advance. Emergency Care in non-VA facilities is provided as a safety net for veterans under specific conditions. You are eligible for payment consideration, if the non-VA emergency care is for a service connected condition or, if enrolled at a VA Medical Center, you have been provided care by a VA clinician or provider within the past 24 months and have no other health coverage. Also, it must be determined that VA health care facilities were not feasibly available; that a delay in medical attention would have endangered your life or health, and that you are personally liable for the cost of services. VA will not pay for care beyond medical stabilization at which time the veteran can be transferred to a VA facility. Time limits apply.
