## "HOMELAND SECURITY"

Each Post should have an appointed Chairman for Homeland Security and Civil Preparedness. This name should have been forwarded to the Department Headquarters (attn: Barbara Kerr).

First, the post should check with local officials to see if they have an emergency/disaster plan in place. Ask how your post can help. Volunteer the use of the post building in emergency or disaster situations. Get member of the post to attend CERT (Community Emergency Response Teams) training. This training is 20 hours and they must attend all sessions. Many posts in Nassau and Suffolk have had this training. I am requesting that each County Chairman let me know what their counties are doing, please have the report to me at least one week before the scheduled district meeting. Local volunteers are necessary for the hardest and longest part of any terrorist attack, or natural disaster, the recovery phase. Local volunteer know how the area was before the attack or disaster and they know the best ways around any blockage of roads or other obstacles. Volunteers should only take on jobs or tasks that they are qualified to do, this way the risk of someone being hurt or worst is minimized.

Homeland Security is not only about Terrorism, it covers disasters such as, floods, hurricanes, train derailments, fire, snowstorms etc. The posts and CERT personnel can be a tremendous help in times of emergency. The cornerstone of preparedness and prevention is AWARENESS for all hazards. It requires everyone's help. The skills, training and education that veterans have make your observations and involvement even more critical. Watch for suspicious activity...if you see something, say something.

Terrorism has many formal definitions. In most it involves illegal activity, including use of force or violence directed against the civilian population. It is intended to coerce or intimidate a government or civilian populations or noncombatants in furtherance of terrorist political/social objectives. Terrorism can be domestic, international, state-sponsored or loosely affiliated. The bottom line is "ALWAYS BE ALERT AND IF YOU SEE SOMETHING, SAY SOMETHING".

I shipped two (2) packages to service members whose names and addresses were supplied to me by Joe Slattery. I have shipped the following to the 3-17 CAV in February Five boxes of items I received packed in shoe boxes by the Mill Neck Manor School for the Deaf. These items were given to the Robert Spittel Post 1285 and I handled the shipment. Later I packaged up seven (7) boxers of items I received from PCC Ken Cadieux. I just about wiped his stock out and I would like to transfer \$500 from Family Support to Rehabilitation so they can purchase more items. PCC Ken Cadieux gets the money to buy the items from the Rehabilitation program.

The unit has been in Iraq for about nine (9) months and they are on a fifteen (15) tour. I will be looking for another unit to adopt. The packages must be addressed to an individual and that person then distributes the items.

### Flags for Memorial Day Graves

County Executive Thomas R. Suozzi has announced that veterans organizations wishing to place small American Flags on the graves of veterans on Memorial Day can secure those flags from the Veterans Service Agency. Although the Long Island National Cemetery in Farmingdale provides the majority of gravesite flags for Memorial Day observances a shortages of flags was reported last year and the cemetery expects to be short again this year. Veterans organizations wishing to secure flags for the honoring of veterans graves should send a letter stating how many flags are required to Edward G. ### OIF/OEF Veterans Benefit and Jobs Fair

The Cradle of Aviation, Charles Lindbergh Boulevard, East Garden City, NY will be the site of the three Benefit and Jobs Fairs in 2008. The first event will be held Monday, March 17, 2008 from 9 am to 1 pm. Representatives from the US Department of Veterans Affairs, VA Medical Center, New York State Departments of Labor and Veterans Affairs, Nassau Community College, MTA Long Island Bus, National Grid, and Long Island Jewish Health System and other employers will be there to advise, assist or hire veterans. Reservists, National Guard and active duty short timers are welcome.

### Working for Nassau County

There are many Civil Service jobs available that you can acquire by taking a Civil Service examination. You can monitor these upcoming examinations by completing the following steps:

- 1) Access the website at [www.nassaucountyny.gov](http://www.nassaucountyny.gov)
- 2) Click on the "Departments" Icon
- 3) Click on the "Civil Service Department" Icon
- 4) Click on "Upcoming Exams."

All the exams will be listed. Access and complete the test application if you qualify. Either print out (and mail or hand deliver) the test application from the website or go to Civil Service Headquarters located at 40 Main St. Hempstead - 2<sup>nd</sup> floor. The exams encompass multiple choice formats and they usually allot you 4-8 hours for the test. The exams are graded within 6 months. Usually, if you score within the top 5% of test takers, you will be considered (canvassed) from the list to go on an interview with the department that chose you. Disabled and non-disabled veterans who wish to use war time credits must claim these credits when filing an application.

The main contact number at Civil Service is 516-572-1882. You may call with any questions you may have regarding upcoming exams.

### Gold Star Annuity

Parents who have lost a son or daughter in the current or previous wars who are residents of New York State and have an income less than \$20,800 (single)/\$28,000 (couple) are eligible for an annual annuity of \$500 per Gold Star Parent. The annuity is capped at \$1,000 per service member and the program is administered by the New York State Division of Veterans Affairs.

In order to be approved for the Gold Star Parent Annuity the applicant must complete and submit to the Division the following:

- Application Form
- Evidence of Military Service of the Deceased Veteran
- Copy of previous years Federal Income Tax Return or a fully executed affirmation, which certifies that the applicant was not required to file a federal Tax Return
- Direct Deposit Form
- Proof of NYS Residency.

### POSTAL RATES: Beginning 3 MAR

Military families will get a price break on the U.S. Postal Service's flat-rate shipping boxes to send care packages around the globe. The discount applies only to the new "Priority Mail Large Flat-Rate Box," which normally carries a \$12.95 price tag for shipping. However, when the 12-by-12-by-5.5-inch box is sent to an AFO or FPO address, a \$2 discount applies, dropping the cost to \$10.95. The new boxes will be available in post offices nationwide on 3 MAR. Those who can't wait to start packing the boxes, however, can order them from [www.usps.com/supplies](http://www.usps.com/supplies) beginning 20 FEB. They're also available by calling 1(800) 610-8734. Some of the new boxes carry the America Supports You logo. America Supports You is a Defense Department program connecting citizens and companies with servicemembers and their families serving at home and abroad. The boxes bearing the America Supports You logo will be Available only online or at select post offices near military bases. All flat-rate boxes are available for international shipping, though the discount applies only to the large flat-rate box, and only if it's being shipped to an APO or FPO address.
