The House of Representatives and Senate have returned from their summer vacations.

On the state level: The Funeral Protection Legislation that passed both the Assembly and the Senate was laid on Governor Cuomo’s desk last week. These two pieces of legislation will create a statewide buffer zone at funerals to protect against disruptions and disturbances as well as allowing localities to establish a permitting procedure for those who wish to protest at a funeral. The Governor had until today to make a decision on this legislation. As of tonight I have not heard what the Governor’s decision was or is.

“HOMELAND SECURITY”

I have stated in all my reports for Homeland Security that we need to be aware of natural disaster besides terrorists. Also I have always stated “IF YOU SEE SOMETHING, SAY SOMETHING”. This is seven signs of Terrorism

1. **SURVEILLANCE:** Recording or monitoring activities, taking pictures, making drawing.
2. **UNUSUAL QUESTIONING:** Attempts to gain information about operations, staffing, security.
3. **TESTS OF SECURITY:** Any attempts to measure reaction times to entering restricted areas.
4. **ACQUIRING SUPPLIES:** Obtaining explosives, weapons, uniforms, badges, credentials, etc.
5. **SUSPICIOUS PERSONS OUT OF PLACE:** People who are in places they should not be, or do not fit into the usual routine.
6. **DRY OR TRIAL RUN:** putting people into position and moving them around without actually committing a terrorist act.
7. **DEPLOYING ASSETS:** People and supplies getting into position to commit the act.

Report any suspicious activity to the Terrorism Tips Line at 1-866-DAFE-NYS (1-866-723-3779) or to the local authorities.

The bottom line is **“ALWAYS BE ALERT AND IF YOU SEE SOMETHING, SAY SOMETHING”**.
